ABOUT THE COMPANY

Founded in 1996 by Mr. RK Agrawal in Betul District of Madhya Pradesh.

Earlier ventures in the company included wire binding unit and plywood manufacturing unit.

The company ventured into Seed Production in 2013 to take advantage of its rich agriculture based location and has since transformed itself into a new generation seed company.

Company now has 1.2 lakh square feet of land on its name on the main National Highway from Betul to Bhopal and has well developed storage and processing facilities.

Company is currently focused on producing high quality field crop products and is among the market leaders in soybean seed production country wide. We have touched production of 70000 Quintals of soybean seed this year.

Company has covered 5 states for sales and is among the top 7 soybean seed producers in the country now.

Company has partnered with all top field crop brands and government seed corporations in the country including MSSC, KSSC, TSSC among others.

PRESENT SCENARIO AND PAST ACCOMPLISHMETS

We are currently focused on producing high quality field crop products and we have gradually expanded our capacity over the years to produce, process and pack over 1 lac quintal of field crop seeds annually.

We are the leaders in production of upcoming notified varieties of soybean seed. We have 50 pc of total quantity available in MP state of new varieties such as Kds 726 which is the most recent popular variety in Maharashtra State developed by Rahuri University, Maharashtra.

We have successfully acquired approvals of 3 new research varieties in soybean and wheat crop by conducting state level University Trials in Maharashtra state.

We have continuously grown at a high pace for the past 7 years exhibiting CAGR of 40 pc in revenues. Our current revenues have touched 51 Crs this year till date.

We were the top supplier to Maharashtra State Seed Corporation from Madhya Pradesh from 2018 to 2020. MSSC was the biggest player in national soybean seed market for several years.

In private sector we have co marketed with Eagle Seeds, Ankur Seeds and Zuari FarmHub who are among the top players in the field crop seed industry.
